RECOMMENDATIONS FOR BATHROOM AT PT. PINOS LIGHTHOUSE:

PULL CHAIN REPRODUCTION TOILET (OAK/BRASS) PURCHASED
AND PAID FOR--\$1,003.46. TO BE INSTALLED BY MUSEUM.
SMALL CABINET (OAK), TO THE PERIOD, TO HOLD SUPPLIES.
BE PLACED BETWEEN OUTSIDE WALL & LAVATORY.
MIRROR OF THE PERIOD OVER LAVATORY.
APPROPRIATE TOILET PAPER, PAPER TOWEL DISPENSER AND
LIQUID SOAP DISPENSER.
APPROPRIATE WASTE PAPER CONTAINER.
LIGHT FIXTURES TO THE PERIOD.
WINDOW COVERINGS TO THE PERIOD.
PERIOD TOWEL RACK WITH LINEN TOWELS (TURN OF CENTURY)
FOR DISPLAY ONLY.
AT SOME FUTURE DATE A PEDESTAL LAVATORY SHOULD BE
INSTALLED. NEW PERIOD FAUCETS CAN BE INSTALLED ON
EXISTING LAVATORY AT PRESENT.

WE, AS QUESTERS, ARE UNDER PRESSURE TO COMPLETE THE
ABOVE, IF THAT IS YOUR DECISION STEVE. TO RECEIVE THE
BALANCE OF OUR CAL. STATE QUESTER GRANT WE WILL HAVE TO HAVE
A YES OR NO FROM YOU BY AUG. 15, 1997 OR WE WILL NOT HAVE
THE FUNDS TO PROCEED. WE WOULD LOVE TO SEE THIS ROOM
