Thank you for giving First Alarm the opportunity to present this proposal for the fire system. Per our meeting this proposal is to replace the existing fire system in the same locations for the control panel, horn strobes and pull station. As we discussed we can relocate the smoke detectors in the same rooms. Since we are replacing like for like and making no changes to the fire system fire plans and a permit should not be required from the fire marshal.

Our Fire System Fire System Proposal contains the following.

- 1 Fire Control Panel
- 1 Pull Station
- 14 Wireless Smoke Detector
- 1 Annunciator
- 2 Horn Strobe
- 1 Wireless Receiver
- 2 Standby Batteries
- 2 Telephone Connections One Line needs to be dedicated Labor, wire and connecting hardware

Total cost comes to **\$ 4,125.00** 

First Alarm owned system installation fee \$ 1,235.00 plus \$ 120.00 per month includes monitoring with daily timer test and inspection per fire code.

Monthly Monitoring fee includes daily timer test and fire system inspection per code \$ 49.00. Purchased system

### **Options**

First Net communication Installation fee \$ 250.00 plus an additional \$ 40.00 per month. Using this option phones lines are not required. This is first alarms own communication network. This takes communication off the grid. We are not reliant on any telephone or cellular provider.

This system will allow you to add your future buildings for both fire and security. And control the security portion of each building independently of each other. Additionally are you can add are a virtual keypad. This is the ability to control the security system portion of the system from your smart phone.
